## The risks for employers

For most drivers of cars and light vans, their driving test was the first and last time that their driving ability was ever formally assessed. Without any further training, many drivers then embark on a career in which driving is an essential task, carried out amid a range of pressures for which they have not been adequately prepared. Many employers are aware of this, either from the results of driver risk assessments or the gathering of telematics data, but do not fully appreciate the seriousness of the consequences that may result from a failure to intervene when concerns have been identified.

# Work journeys account for nearly 1 in 3 UK road deaths




In 2019, 520 people died in collisions involving a driver or rider driving for work – 29% of the total number of road deaths<sup>1</sup>.

## Company drivers rack up an estimated 1.3 million penalties in a year



In 2021, leasing companies received and processed an estimated 1.3 million fines, with a total value of £68m, and charged around £27m in admin fees<sup>2</sup>.

## Failure to act on risk data puts fleets in danger of prosecution



Many employers know when a driver is high-risk, but failure to take remedial action can be costly. One bus operator, whose repeated failure to act on a particular driver's poor telematics data, was fined £2.3 million after the driver went on to kill a passenger and a pedestrian.

### Theory presentation

### **Eyesight and vehicle checks**

It's essential that we verify vehicle and driver are roadworthy.

Session 01



#### First on-road lesson: Eco-driving

Two drives of the same route, comparing the efficiency of normal driving vs eco driving. Debrief, discussion, analysis of the results of Eco-driving, followed by a demo drive by the trainer, reinforcing the information each delegate has been given.

Break time - Decompress, relax, and let the information that has been received so far to soak in.

Session 02



## Principles of safe driving

An introduction to the three fundamentals of defensive driving: Observation, Anticipation, and Planning (OAP).



### **Confined space manoeuvring**

Equips delegates with a systematic approach to parking and manoeuvring.



## Combining and reinforcing skills

Each delegate's' opportunity to develop skills learned so far, plus management of risk through correct use of space and speed, and discussion of attitudes and their effects on risk.



#### Discussion of the course

Reflecting on their performance, as well as any areas that would especially benefit from further development.

The trainer provides a full Driver Evaluation Report for each trainee, detailing their performance and highlighting any development areas. A copy is provided for their employee record.

#### What will I need to bring?

You will need to attend in your own vehicle; ideally the one that you drive for work, and you will need to bring your driving licence. Remember to wear your glasses if you need them for driving; an eyesight check is always carried out at the start of our on-road courses.

#### Can I do the course in my van?

Our trainers are Approved Driving Instructors, who are skilled at applying the principles of Driving for Work across a range of vehicle types. For more in-depth training on the finer points of van driving, we also offer modules focusing on vehicle familiarisation, and on manoeuvring in confined spaces.

#### Is it a test?

There is no test to pass. Our instructor will observe your driving skills and behaviours, and offer constructive advice throughout the course. They will also complete a Driver Evaluation Report for you and your employer, confirming that you have completed the course, and recommending any areas for further skills development if applicable.

### What about EVs and hybrids?

The safer driving principles covered in Driving for Work are applicable across all engine types, and the techniques taught in the eco-driving session also have benefits for optimising battery life in hybrid and fully electric vehicles.
